# 152 POLICE MATTERS

There were currently no PCSOs available for this area and there were, therefore, no Police matters to report on this occasion.

# 153 FLOOD ALLEVIATION - BRADFIELD GREEN

At the previous meeting, the Clerk had been asked to submit a Freedom of Information request to Cheshire East Council (CEC) to provide specific information about the drainage scheme at Bradfield Green.

Prior to submitting the request, the Clerk contacted the Freedom of Information (FoI) Officer at Cheshire East Council who advised that this type of information fell within the Environment Regulations which allowed a total of 40 days to provide the information.

Notwithstanding that a formal Fol request had not been submitted, the majority of the information requested had been provided and forwarded to Members on 29 January 2016. Subsequent to that, the Chairman had suggested that further information was required; namely a copy of (a) the letter of approval of the grant; and (b) the application form for the grant. This had not yet been provided.

**RESOLVED:** That a formal request under the Environmental Information Regulations 2004 be submitted to Cheshire East Council requesting (a) the letter of approval of the grant; (b) the application form for the grant; and (c) the name of the organisation funding the scheme.

# **Neighbourhood Plan (Minute 124)**

In January 2016, a press release had been issued to local media as a 'last call for action' to residents wishing to proceed with a Neighbourhood Plan for the parish. A deadline date of 29 February 2016 was given. No requests had yet been made.

# 157.2 Playground Equipment – James Atkinson Way (Minute 125)

The order for playground equipment at James Atkinson Way had been placed with ANSA (independent arm of CEC). The Clerk had followed this up with the team and reported that the supplier had now offered the same equipment in HPL (high pressure laminate) which was considered to be a better solution than wood.

During discussion, Members were informed that Bentley Motors was offering a grant of £48,000 for improvements to the James Atkinson Way playground. It was agreed that this matter be deferred pending receive of further information.

**RESOLVED:** (a) That the Clerk make enquiries about the availability of the grant from Bentley Motors for improvement of the playground at James Atkinson Way; and

(b) That the matter be deferred until further information was available.

### 158 REPORTS/SHARED INFORMATION

- Woolstanwood roundabout. A resident had commented on speeding traffic and had requested the installation of a vehicle-speed display sign. The provision of such a sign would need to be funded through the Ward Councillors' minor works budget.
