#### **142 WAR MEMORIAL DEDICATION CEREMONY – JUNE 2016**

At the previous meeting, the Clerk had been asked to enquire if there were any restrictions in respect of the addition of names to war memorials which would dictate that the names of the deceased must be of those who had resided in the parish in which the war memorial was located.

A copy of guidance from the War Memorials Trust was now submitted and did not indicate that there were any restrictions.

Arising out of discussion, Members were informed that Steve Bratt would be making a presentation to the Crewe History Society on 9 February 2015 (7.00 pm) in respect of the air crashes in the parish.

There was a brief discussion about arrangements for the next meeting of the Working Group.

It was reported that Borough Councillor Rachel Bailey had been elected as the new Leader of Cheshire East Council, subject to confirmation by Full Council on 25 February 2016.

**144 EXTERMINATION OF MOLES AT BRADFIELD GREEN**

At the previous meeting, it was reported that there was evidence of mole activity at Bradfield Green. The Parish Council was invited to consider if action should be taken to exterminate the moles.

Following discussion, Members agreed to hold the matter in abeyance for two months. In the meantime, the Clerk would make enquiries and seek a quotation from a company other than that which had been employed on the previous occasion.
