680 DECLARATIONS OF INTERESTS

Members were invited to declare any disclosable pecuniary interests which they had in any item of business on the agenda, the nature of that interest, and, if necessary, to leave the meeting prior to the discussion of that item.

No declarations were made.

681 CREWE COMMUNITY GOVERNANCE REVIEW

The Borough Council had undertaken a Community Governance Review of the unparished areas of Crewe and had now produced draft recommendations for the creation of a new parish with a Town Council to be named Crewe Town Council. The new parish would come into effect on 1 April 2013, with elections to Crewe Town Council being held on 4 April 2013.

As part of the review, electors in the unparished part of Leighton had been asked by way of a formal ballot to indicate whether they wished to be part of the Crewe Town Council area or the existing Minshull Vernon and District Parish Council area.

The results of that survey were submitted to the meeting and it was noted that of the 77 voting papers received, 11 wished to be included in the Crewe Town Council area and 66 in the Minshull Vernon & District Parish Council area.

Following this result, Cheshire East Council's Community Governance Review Sub-Committee would be recommending to the Constitution Committee, at its meeting to be held on 20 September, that the unparished area comprising polling district 1FJ4, form part of the existing Leighton Parish and Leighton Urban ward of Minshull Vernon and District Parish Council.

The Constitution Committee would, in turn, make its recommendations to Full Council on 11 October 2012.

The Parish Council was invited to comment on this proposal.

RESOLVED: That the Parish Council support the proposal that the unparished area comprising polling district 1FJ4 form part of the existing Leighton Parish and Leighton Urban ward of Minshull Vernon and District Parish Council.
